MICHIGAN DOLPHINS REFUNDS

The Michigan Dolphins operates as a 501 ©(3) nonprofit organization. We keep registration costs as low as possible while still offering an excellent experience for players.

Prior to the season we use player registration fees to fund our operating budget, which includes uniforms, equipment, field maintenance, and league fees in order to operate our organization needs player fees prior to the season.

The undersigned parent/guardian of the registered Michigan Dolphins football player of cheerleader noted below, hereby understands and agrees to:

- I agree that if I request a refund from Michigan Dolphins, it will be paid as follows:
 - July 1st-23rd- 50% refund given back **ONLY** if said age group winds up not having enough youth for a full roster. There are NO refunds under any other circumstances.
 - Any date after July 23rd: NO refund given
- I agree that Michigan Dolphins and Detroit PAL/AYF cannot guarantee or cover costs associated with any injury that results in a registered athlete sitting out for a portion of or the entire season.
- I agree to return all Michigan Dolphins property/equipment in my possession NO LATER than the announced Equipment Turn-In date at the end of the season.
- In the event of a registered athlete's resignation or expulsion, I agree to return the equipment within 24 hours.
- I agree that failure to return Michigan Dolphins property/equipment may result in legal action for which I will assume all associated legal costs.
- I agree that I will be obligated to pay for lost, stolen, or damaged items due to neglect.

Personality Incompatibility: I understand that the Michigan Dolphins Board, staff and coaches are all unpaid volunteers. I also understand that sometimes disagreements arise between parents and youth sports coaches over a variety of issues. I understand that the Michigan Dolphins will not issue any refund whatsoever if I withdraw my child from the program due to personality or other disputes as between or among my child's coach, myself and/or the Michigan Dolphins Executive Board.

Parental Misconduct: If I am asked to leave the program at any time for misconduct, including, but not limited to, a violation of the Code of Conduct, ***no refund will be issued whatsoever.***

Discipline: One of the purposes of youth sports is to instill a sense of order and discipline. I understand that if my child is unruly or excessively disruptive to the point that it interferes with the orderly conduct of the team, his or her coach will first discuss this with me. If my child's conduct does not thereafter improve, he may be asked to leave the team. I understand that if this occurs, ***I will not be entitled to any refund.***
